

**COLLINS, David.** AN ACCOUNT OF THE ENGLISH COLONY IN NEW SOUTH WALES, from its first Settlement in January 1788, to August 1801: with Remarks on the Dispositions, Customs, Manners, &c. of the Native Inhabitants... *Two volumes, quarto, two maps, 23 plates, (three coloured) and eight half-page engravings (two coloured), the New Zealand chart with a marginal tear and laid down on fine linen, several plates remargined at the head, a little scattered foxing and a couple of discrete shelf labels on endpapers, with both half-titles, overall a handsome set in fine contemporary speckled calf, rebacked in period style by Aquarius, preserving original labels, London, Printed by A. Strahan for T. Cadell and W. Davies, 1798 – 1802. First editions and extremely scarce. Collins's First Fleet account is the earliest history of colonised Australia, and contains the most detailed and painstaking of all descriptions of the voyage and first years of settlement in any of the early accounts. The rare second volume was based on Governor Hunter's papers, supplemented by the official records and despatches. As well, Collins had access to the journals of Bass and Flinders, which he reproduces in detail – this was the only publication of Bass's journal. Ferguson, 263 & 350; Wantrup, 19-20.*


**DARWIN, Charles, Phillip Parker KING, and Robert FITZROY.** NARRATIVE OF THE SURVEYING VOYAGES OF HIS MAJESTY'S SHIPS ADVENTURE AND BEAGLE, between the Years 1826 and 1836, describing their Examination of the Southern Shores of South America, and the Beagle's Circumnavigation of the Globe. Three volumes in four (including Appendix to the second volume), octavo, with 48 etched and engraved plates and charts (one folding) after P.P. King, R. Fitzroy, A. Earle, C. Martens, T. Landseer, and others, eight folding engraved maps, six text woodcuts, half-titles in volumes 1 and 3 (none called for in the Appendix), occasional foxing and marking, several pencilled marginal notes, the Narrative and Appendix in matching contemporary half calf (rubbed) and marbled boards, all edges marbled, the first volume expertly rebacked, the second with neat repair at head of spine (showing earlier crease), the Journal with a name erased at head of title, in handsome non-matched later half calf and marbled boards, all edges marbled. London, Henry Colburn, 1839.

First edition; second state of the third volume, Charles Darwin's first book, *Journal of Researches into the Geology and Natural History of the Various Countries Visited by H.M.S. Beagle*. The first two volumes of this complete set comprise the official commanders' narratives of the proceedings of the two expeditions, 1826-1830 under the command of Captain Phillip Parker King, and 1831-1836 under the command of Captain Robert Fitz-Roy.

The *Voyage of the Beagle* is generally regarded as scientifically and intellectually the most important travel book of all time, providing the evidence for what would become Darwin's life-long quest to uncover the processes of evolution that has had such a profound effect on mankind in all spheres of human activity. For Darwin, the voyage of the *Beagle* was "by far the most important event in my life, and has determined my whole career" (*Life and Letters* 1:61).

As is usual with copies of the complete work sold by Colburn from late 1839 the Darwin volume is in the second state with an expanded title and without reference to its being the third volume of the complete narrative. By 1841 at least, Colburn was advertising the King and Fitzroy narrative as available in two volumes, quite separate from the Darwin journal which had been offered separately under its expanded title from at least August 1839. **FREYCINET, Louis Claude de Saulces de.** SIGNED, MANUSCRIPT LETTER FROM FREYCINET to Mr Fleurieu, ministry of navy and colonies, regarding the earlier loss of the corvette the Uranie. *Foolscap folio, manuscript letter, one page on one leaf (old folds). Paris, 3 Juillet, 1838.* An interesting letter from the great navigator, perhaps the greatest of the nineteenth-century French *grands voyageurs.* The letter relates to the official inquiry into the wreck of l'*Uranie* towards the conclusion of the expedition. In 1838 Freycinet was finalising the last "partie" of his official narrative of his great expedition in l'*Uranie* and in this letter he sought a copy of the official judgement on the wreck of his vessel. A pencilled note on the letter by an official indicates that his request had been satisfied. Letters signed by Freycinet are uncommon, especially when they have such a crucial place in the story of his *grand voyage* account, published between 1825 and 1844.

An extremely scarce and sought after exploration pamphlet: inscribed family presentation copy, signed and dated 1934 by the author's son. Giles was second-in-command of the Northern Territory expedition to fix the course of the Overland Telegraph line under John Ross, making the crossing from Adelaide to Darwin seven times. This volume expands on a series of articles Giles wrote for the <i>Adelaide Register* over 1925 and was compiled from his notebooks. The printer-publisher's copy, formerly in the collection of Harry Muir and later handled by us, noted the cost of 50 copies in cloth, 200 copies in wrappers. Rare: one of the earliest European gold field guides, a compilation of material intended to promote a Tuscan expedition to the gold mines, published in Florence in 1853. It is not known whether the proposed venture came to fruition. This is a presentation copy, inscribed on the front wrapper "All' Egregio Sigr. Marchese Gargoni". According to a note in the copy in the National Library of Australia, Ragguagli delle Cose dell'Australia al Cominciare dell'Anno 1853 (Information on Conditions in Australia at the beginning of the year 1853) was compiled by Francesco Paolo Ruggiero but the authorship is not of overriding importance. The compiler provides a general description of Australia with a more detailed account of the gold regions and their commercial prospects. Ferguson, 15203; Wantrup, 389.



TENCH, Watkin. A NARRATIVE OF THE EXPEDITION TO BOTANY BAY; with an Account of New South Wales, its productions, inhabitants, &c. to which is subjoined, A List of the Civil and Military Establishments at Port Jackson. Octavo, a few leaves closely trimmed (slightly affecting the text on pp. 53-4), lacking half-title and terminal leaf of advertisements (although this is not called for by Ferguson), re-inserted in old half calf and marbled boards (rebacked with some restoration). The first edition: always the scarcest of the First Fleet accounts this first edition is now rarely seen and vastly more difficult for the collector than any of the other First Fleet journals. Tench's 1789 narrative is the earliest, and arguably the best written, eyewitness account of the first European settlement of Australia. White's journal apart, the others are more or less official in tone; none has the directness of Tench's description of life in the first days of the colony. Apart from its importance as the first genuine description of the new colony, Tench's narrative provides us with the clearest of the surviving images of the first crucial months of settlement. London, J. Debrett, 1790. Deluxe handcoloured issue of the celebrated First Fleet journal with the fine natural history plates on Whatman paper and in original publisher's handcolouring. In this special handcoloured form, it is the earliest and one of the best and most appealing of Australian colour-illustrated natural history books. John White, chief surgeon on the First Fleet, commenced his journal with the sailing of the First Fleet and continued his often personal chronicle through the first ten months of settlement at Sydney Cove, including "many circumstances omitted by Governor Arthur Phillip and others" (Hill). Melbourne, Charles Stuart, 1887-1890-1891. A complete set of the parts issue. Broinowski's best-known work was designed to bring Australian ornithology to a much wider audience than could be reached by Gould's expensive series of handcoloured lithographs published thirty years earlier. Broinowski's production of over three hundred chromolithographs in Australia in 1890 was an exceptional undertaking and his book a monument both to Australian printing technology and to the author's remarkable enthusiasm. The following eleven lots comprise the remaining archive inherited by the historian Edgar Beale from his Great-Great-Grandmother Sarah Turner (née Allatson) and his Great-Grandfather Alfred Allatson Turner. The archive has remained firmly in the hands of seven generations of the family. In our last sale (August 2024) we sold Kennedy's fine self-portrait and his beautiful watercolour portraits of his lover, Margaret Murphy, together with books assembled by Edgar Beale for his studies of Edmund Kennedy. After Kennedy was murdered by Aborigines in north Queensland his personal possessions came to his friend and 'landlady' Sarah Turner and from her to her son, Kennedy's friend and fellow explorer, Alfred Allatson Turner, ancestor of Edgar Beale. The archive includes a superbly associated copy of William Carron's account of Kennedy's fatal last expedition belonging to Sarah Turner. Apart from Kennedy's courageous and loyal Aboriginal companion, Jackey-Jackey, Carron was one of only two survivors.



**KENNEDY, Edmund Besley Court.** ORIGINAL 1842 FIELD BOOK OF SURVEY NOTES IN PORTLAND (Victoria) AND SURROUNDS. Original manuscript of 223 pages, mainly pencil, with 20 pages in ink, one blank leaf at rear roughly removed, later page numbering neatly added in pencil (showing that one original leaf of text was already lost), original oblong leather notebook, worn and with splits and ink marking, the hinges split, with the label of manufacturer Cowan and Co, Edinburgh. [Portland, 1842].

Kennedy arrived in Portland on 22 December 1840. A young man of 22, and a newly qualified surveyor, he had been placed by Sir George Gipps under the command of Charles Tyers. Their overland trip from Sydney to Melbourne was ten weeks, and the second leg to Portland a further four. They reached a township consisting of "one good house, and six decent cottages, besides a few huts" according to the recently arrived Police Magistrate. There were just over 100 residents, but more than 600 in the district.

Kennedy's field work involved periods of camping while he surveyed the rivers, fixed boundaries of pastoral runs, and performed the general survey work of marking out roads, interspersed with periods in Portland during which he was compiling the maps and office work. His field notebook records over twenty separate trips, with starting points including Grange Burn, Camp at Mt Rouse, and Peg at Brook's Creek. While the manuscript entries are largely numerical, at the same time he notes vegetation (banksia and blackwood, good forest land, fine forest land, swampy flats, thick forest eucalypts) and watercourses which he also shows sketchily, as well as noting features such as a ford, bridge, and stony rise. Measurements are sometimes shown in miles, and a list shows "the bearings of the following hills... taken from Mt. Bainbrigge on a very squally day– Mt. Napier, Mt. Pierrepoint, Mt. Sturgeon, Mt. Abrupt, Mt. Victoria, High Point of Dundas, Sugarloaf of Mt. Dundas, Mt. Eckersley." Cameron's hut, Kennedy's hut and Patterson's station on the Grange are all mentioned. Only one date is noted: Camp at Marked Tree on Grange Burn for Variations, 7th April 1842.

Sir Thomas MITCHELL.** KENNEDY'S ORIGINAL 1846 FIELD BOOK OF SURVEY NOTES as Second-in-Command on Mitchell's fourth expedition. *Original pencil manuscript of 184 pages, 34 of which are overwritten with unrelated subsequent ink notes and sketches, later page numbering neatly added in pencil by Beale, original oblong leather notebook approximately 11 x 18 cms, rubbed and with some loss of surface including the spine, with repaired metal clasp [with] an accompanying notebook.* 

In 1843 the colonial government proposed an expedition to discover an overland route to the settlement at Port Essington on the north coast, which had been established in 1838 as a trading port. In 1845 Mitchell was given command of an expedition and he set out in December with Edmund Kennedy as second-in-command. Over the next twelve months Mitchell explored a vast area of unknown country in tropical Queensland, returning to Sydney on 29 December 1846. Mitchell did not find an overland route to Port Essington and seemed more intent on discovering the great north flowing river he still obstinately believed in. Needless to say he found none, although he represented the "Victoria" as his imagined river in the published account of the expedition. Mitchell's "Victoria" was in fact the Barcoo and not, as he too hastily concluded, the headwaters of the Victoria River which Stokes had recently discovered flowing into the sea on the north coast.

This notebook of Kennedy's starts on 7 April 1846 "from Peg at Camp 1, no. 4 on a Creek abt 1 mile west of the Balonne". The pencilled text is mainly measurements, sometimes a bit faint, with notes of vegetation and natural features: myall scrub, white gum forest, pines with iron bark, sand, swamps: as well as numbering of some of the party's camps, including a reference to "Sir T's 1st Camp", and some topographical indications. There is no stated end date, and it seems likely that the text starting on 7 April is actually a continuation from the accompanying second notebook of 175 pages in identical format. This second book has faint survey entries on only around 20 of its pages, the balance appearing to be erased before being overwritten with subsequent study notes of Latin translation, arithmetic calculations, and scribble; later page numbering neatly added in pencil by Beale: the outer board bears the just legible inked name of a young E.H. Turner, Wollongong.

The night before sailing to Rockingham Bay Kennedy wrote "The Rev. W.B. Clarke has offered to send a paper to the Geograp. Society giving an account of my late journey on condition that I let him have my journal to take the particulars from. I think I shall accept the offer."

After Kennedy's death Captain Owen Stanley asked the Colonial Secretary to see that Kennedy's journals and papers were given to Clarke. As Beale states, these are the last known traces of Kennedy's original holograph journal or journals, public or private. "However, Kennedy made a copy of a considerable part of his public journal. This is now in the editor's possession, and bears signs of hurried work, in that the handwriting is not as careful as usual". The journal starts on 1 April 1847, and ends mid-sentence on 13 November. This is the text which Beale prints in his 1983 Blubber Head Press work *Kennedy, The Barcoo and Beyond 1847*, a copy of which is included in the lot.

I take the earliest opportunity of reporting to you the return of myself and party to Mr. Ker's station, on the Bogan, having, in accordance with the instructions contained in your letter of the 22nd February, No. 47-42, followed down the River Victoria, and determined so much of its course as the supply of water and feed for my horses would admit of. You will observe, however, from the following particulars, which I have now the honor to lay before you, that I continued to trace that river, through a desert, to the southward, for more than a hundred miles, when nothing less than a total failure of water and vegetation compelled me, with difficulty and much reluctance, to withdraw.

To enter into " the detail of the results and progress of my journey," and with a view to notice, as fully as possible, each clause in my instructions, I take the liberty of repeating here the heads of each paragraph contained in your letter, replying to them in the order they demanded my attention.

With reference to the first, in which I was directed to "return to the interior from Sydney, "without delay, by the road across Liverpool "Plains, so as to fall into the return track of the "late expedition; to recross the Balonne, at "St. George's Bridge; take the route back to " Camp 83, and thence by the route along the " Maranoa to Camp XXIX," I have only to state that, having left Sydney on the 13th March, and Parramatia on the 21st of the same month, I adhered to the route pointed out without any deviation, and arrived at the Camp referred to, on the Maranoa, on the Sth June.

Coming fresh to the market with a family provenance that stretches seven generations, these manuscripts show the development of Turner's role in Kennedy's Barcoo expedition, from field notes to final draft of the journey.

The two small pocket books are either field notes or a transcription of them: the first is 44 pages of ink text and 20 pages blank, the second 32 pages of text (ink and pencil) with 32 blank.

The working draft shows alterations, deletions, and corrections, the text written in an exercise book of 80 pages (numbered by the author to page 29), the final 16 pages being inserted and loosely sewn. Turner describes the entire journey commencing on 13th March 1847 and arriving back on 7 February 1848.

The fair copy generally repeats the draft and is "more carefully expressed" (Beale p. 98). In this text there are wide margins in which Turner has written substantial supplementary detail.



A SUPERB ASSOCIATION COPY of the first edition, signed on the first blank by Sarah Turner, Sydney, 1849 and again on the title-page in Wollongong (now as Sarah Barton). Sarah was Edgar Beale's great-great-grandmother, the mother of Alfred Allatson Turner, Kennedy's friend and fellow expeditioner on his earlier 1847-1848 trip to the Victoria River. William Carron's account was the only published narrative of the fatal Kennedy expedition to Cape York.

The expedition was a disaster from the start. Kennedy had been given impossible instructions dreamt up by officials who had no idea of the nature of the country to be explored. When the expedition disembarked at Rockingham Bay it was well equipped, with twenty-eight horses, three carts, a hundred sheep and four dogs. But these resources were less than useless in the country they had to traverse. Rain, insects, leeches and the difficulty in clearing a path through the tropical rainforest slowed the party to a crawl.

When it became obvious that the whole party would not reach Cape York in time, Kennedy decided to leave eight members of the party at Weymouth Bay under the command of the botanist, William Carron, while he made a forced

march to Cape York with the Aborigine, Jackey Jackey, and three others. A short time after the advance party left Weymouth Bay one of the men accidentally shot himself. Since he was soon too weak to go on, Kennedy decided to leave him and the two other Europeans at Shelburne Bay while he continued north with Jackey Jackey to seek help.

Early in December a group of Aborigines to whom Kennedy had earlier given some fishhooks and a knife had followed them. Suddenly they attacked. Kennedy's gun would not fire and although Jackey Jackey hit one of the attackers and beat them off, Kennedy was struck in the back and leg by several spears, dying in Jackey Jackey's arms. Over the next few days Jackey Jackey struggled towards safety, dogged all the way by the hostile Aborigines. He reached the shore at Port Albany and attracted the attention of the *Ariel* waiting there for the party. Even as the *Ariel's* boat came to pick him up his pursuers were hot on his heels and he was rescued only just in time. Immediately Captain Dobson of the *Ariel* set off to rescue the survivors. At Shelburne Bay they were too late. A captured canoe showed evidence that the three men left there had already been killed. At Weymouth Bay they found that all but two men, William Carron and William Goddard, had died of starvation. Here the rescuers were just in time. As Captain Dobson, Jackey Jackey, and two other men from the *Ariel* broke through mangroves and hostile Aborigines to reach Carron's camp they found an armed party had entered the camp and were standing with spears poised.

Kennedy's expedition is perhaps the most tragic of all Australian explorations, not least because he and his men were defeated at the outset. The bravery, skill, good humour and generosity of Kennedy, the loyalty and courage of Jackey Jackey, and the endurance of Carron and Goddard all tell of the needless suffering and tragic waste of human life brought about by the ill-conceived instructions they had been given.

William Carron's account was the only published narrative of the expedition, aptly described as "one of the most conspicuous rarities in the literature of Australian land exploration".





The Snowy Mountains Scheme was the single most important event in the promotion of mass emigration to Australia since the gold rushes of the 1850s and arguably the most significant demographic event in the history of the continent. Spurred on by the energy demands of the Government's post-war reconstruction strategy, the establishment of the Snowy Mountains Hydro-Electric Authority was established in 1949 to realise the dream of harnessing the waters of the rivers of Australia's high country to irrigate the Murray and Murrumbidgee areas and, in the process, to generate vast quantities of cheap electricity.

The piece comprises the expected official matter – programme, dignitaries and others, etc. – concluding with an historical and promotional account of the immense project being commenced on pp. 9-31.

The fact that virtually all copies seen have been affected by damp is readily explained: "About 4,000 visitors went to the site near Adaminaby in about 1,200 cars. More than 30 Government cars and several buses made the round trip of more than 200 miles from Canberra. The weather was so bad yesterday it was feared that another site might have to be chosen. Rain and light snow made the road leading to the site almost impassable. But workmen toiled all night carting soil to the approaches and they were quite dry to-day..." (Sydney Morning Herald, 18 October 1949).







The very large dedication cartouche in the southern Indian Ocean includes a self-portrait of Coronelli as well as ornate allegorical figures and cherubs.



It shall be the responsibility of the Buyer to obtain any permit required under the Protection of Movable Cultural Heritage Act 1986, the Wildlife Protection (Regulation of Exports and Imports) Act 1982 and any other legislation, all as amended, which may restrict or prohibit the export of a lot outside a state or the Commonwealth of Australia. Refusal of any permit shall not vitiate the sale and the Buyer shall be bound to take delivery of the lot without an allowance or abatement in price.
- 5a. At the conclusion of the auction the Buyer will immediately pay to the Auctioneer the whole of the Purchase Price. Payment of the Purchase Price shall be made in Australian dollars in cash. Payment by personal cheque or bank cheque in Australian dollars drawn on an Australian bank may be accepted at the Auctioneer's discretion and, unless prior arrangements have been made, must be cleared before delivery of purchases. Credit card payments by Mastercard or Visa, can also be accepted by prior arrangement. Payments made by credit card are subject to an additional charge of 1.1% to cover bank fees and charges. The Buyer will pay interest at a rate of 3% per month on the Purchase Price in the event of the Purchase Price remaining unpaid for more than 24 hours after the sale.
- 5b. Any payments made to the Auctioneer may be applied by the Auctioneer towards any sums owing from that Buyer to the Auctioneer on any account whatever without regard to any direction of the Buyer or his agent, whether express or implied as to how payment should be applied.
- 5c. Should one Buyer purchase more than one lot at the same auction then each contract shall be interdependent with the others and default under one shall be deemed to be default under all the others, unless the Auctioneer should elect otherwise.
- 5d. All lots purchased must be collected from the place of auction at the Buyer's expense not later than noon on the day following the auction and provided the full Purchase Price has been paid to the Auctioneer.
- 5e. If a Buyer has not collected any or all of his purchases by noon of the day following the auction, the Auctioneer may place the property in storage at the Buyer's risk and the Buyer shall be responsible for all removal, storage and insurance charges on such property. Packing, handling and transportation of all purchased lots is entirely at the risk and expense of the Buyer. In no event will the Auctioneer be liable for loss of or damage to purchased lots irrespective of cause, including negligence, notwithstanding that the

property is in the custody and control of the Auctioneer at the time of the occurrence of such loss or damage.

- 5f. In the event of a breach by the Buyer of any of the terms of these Conditions then any deposit or other sums paid to the Auctioneer shall be forfeited and the Auctioneer in his absolute discretion, without prejudice to any other rights or remedies available to him, will be entitled without notice to the Buyer to dispose of the Buyer's purchases by public auction or private treaty and the Buyer shall pay to the Auctioneer any resulting deficiency in the Purchase Price (plus interest) and any other costs incurred as a result of the Buyer's default, including storage, freight, insurance and any other charges whatsoever. Any surplus shall be paid to the Seller.
- Any warranties express or implied on the part of the 6a. Auctioneer or Seller, other than those that are expressly contained in these Conditions, are hereby excluded. Without limiting the generality of the foregoing any representation in any catalogue, advertisement, condition report, or made orally or in writing elsewhere as to authorship, origin, date, age, size, medium, attribution, genuineness, provenance, condition or estimated selling price is a statement of opinion only. Prospective buyers must satisfy themselves as to all matters relating to the condition, description, authenticity and the nature of any lot by inspection or by obtaining any independent expert advice reasonable in view of the buyers particular expertise and the value of the lot prior to the date of the auction and the Buyer must take delivery of the lot with all faults patent or latent (if any). Accordingly, buyers will be deemed to have knowledge of all matters which they could reasonably be expected to find out given their particular expertise and the exercise by them of reasonable due diligence.
- 6b. All conditions, notices, descriptions, statements and other matters concerning a lot are subject to any statement modifying or affecting that lot made by the Auctioneer from the rostrum prior to any bid being accepted on that lot.
- 6c. All lots are sold "as is" and no error or misdescription or deficiency in quantity shall vitiate the sale and the Buyer shall be bound to take delivery of the lot without an allowance or abatement in price.
- 6d. Many lots are of an age or nature that precludes their being in perfect condition and reference may be made in some descriptions to damage, restoration, or defect. Such information is given for guidance only and the absence of such reference does not imply that a lot is free from defects nor does the reference to particular defects imply the absence of others. Illustrations of any lot are for the guidance of prospective buyers and are not to be relied upon to determine either tone or colour of any item or to reveal imperfections (if any).
- 6e. Neither the Auctioneer nor the Seller make any representations or warranties, implied or express, as to whether any lot is subject to copyrights nor whether the Buyer acquires any copyrights, including but not limited to reproduction rights in any lot sold.
- 6f. The Seller gives to Australian Book Auctions full and absolute right to photograph and illustrate any lot consigned for sale and to use such photographs and illustrations at any time at its absolute discretion whether or not in connection with the sale. The Buyer and the Seller acknowledges that the copyright of all photographs taken and illustrations of any lot by Australian Book Auctions shall be the absolute property of Australian Book Auctions.

- 7a. Notwithstanding anything else in these Conditions if within fourteen days of the sale notice in writing from the Buyer is given to the Auctioneer that in the Buyer's opinion the lot is a forgery that at the time of the sale had a value materially less than the Purchase Price then the lot may be returned within a reasonably agreed time to the Auctioneer. Should the Auctioneer be satisfied that:
  - the lot is returned in the same condition as it was at the date of the sale; and
  - (ii) the Buyer establishes that he has not sold or transferred the lot, and that no rights have been created in favour of any third party in respect of that lot; and
  - (iii) the Buyer establishes that the lot is a forgery, that is to say an imitation originally conceived and executed as a whole with a fraudulent intention to deceive as to authorship, age, origin, period, culture or source and where the correct description as to such matters is not fairly reflected by the catalogue description amended by any statement modifying or affecting that lot made by the Auctioneer from the rostrum prior to any bid being accepted on that lot. No lot shall be capable of being a forgery by reason of any damage, restoration of any kind (including pen facsimile), defects of binding, staining, spotting, foxing, oxidisation, toning, absence of blank leaves or list of plates or list of subscribers or advertisement leaves or cancel leaves or errata slips or errata leaves;

then the sale will be rescinded and the amount paid by the Buyer will be refunded.

- 7b. The Buyer shall be entitled to claim under this condition only the Purchase Price, being the hammer price plus the buyer's premium, or part thereof actually paid by the Buyer to the Auctioneer for the lot and shall not include a refund of any sales tax, storage charge, insurance, interest, commissions, or any other costs to the Buyer other than the Purchase Price actually paid and specifically the Buyer shall have no claims for any direct or consequential loss suffered or expense incurred by him.
- 7c. This condition does not apply to any multiple lot, box lot, shelf lot, any uncatalogued lot, or any lot described in the catalogue as sold "not subject to return", or "w.a.f." (i.e. with all faults).
- 7d. The benefit of this condition is a non-assignable exclusive right in favour of the actual Buyer of the lot at the auction and, without limiting the generality of the foregoing, may not be assigned to a third party by a Buyer acting as an agent on behalf of such third party except when in accordance with clause 4c of these Conditions.
- 7e. The Buyer shall not be entitled to claim under this condition if he is in breach of any of the terms of these Conditions.
- 7f. The terms of this condition shall not operate so as to exclude such conditions or warranties as are implied by state of federal law and which cannot legally be excluded or where such exclusion would render any contract with the Buyer, or any part of such a contract, void or voidable.
- 8a. These Conditions of Business shall be governed and construed in accordance with the laws of the State of Victoria, Australia, and all parties concerned hereby submit to the exclusive jurisdiction of the courts of that state.
- 8b. If any part of these Conditions of Business is found by any court to be invalid, illegal or unenforceable, that part may be discounted and the rest of the conditions shall continue to be valid and enforceable to the fullest extent permitted by law.
